Congressman Mack visits Honduras

WASHINGTON Congressman Connie Mack (FL-14), the Ranking Republican of the House Subcommittee on the Western Hemisphere, released a report summarizing his recent Congressional Delegation trip to Honduras.

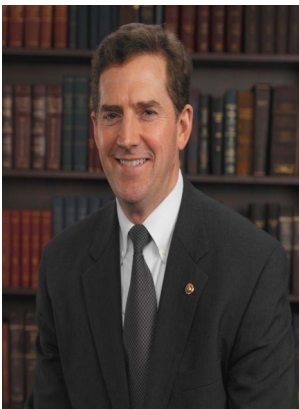
Mack led a delegation to Honduras the weekend of July 25-26, 2009 to see first hand what the situation in the country was and to determine what happened in the events leading to former President Manuel Zelaya's removal on June 28th.

During the trip, Mack met with the current Honduran President Roberto Micheletti, Members of the Supreme Court, Members of the Honduran National Congress, human rights organizations, American and Honduran business leaders, and the U.S. Ambassador to Honduras.

What I heard in Honduras Senator Jim DeMint

In the last three months, much has been made of a supposed military "coup" that whisked former Honduran President Manuel Zelaya from power and the supposed chaos it has created.

After visiting Tegucigalpa last week and meeting with a cross section of leaders from Honduras's government, business community, and civil society, I can report there is no chaos there. There is, however, chaos to spare in the Obama administration's policy toward our poor and loyal allies in Honduras.

The Obama policy was set in a snap decision the day Mr. Zelaya was removed from office, without a full assessment of either the facts or reliable legal analysis of the constitutional provisions at issue. Three

months later, it remains in force, despite mounting evidence of its moral and legal incoherence.

While in Honduras, I spoke to dozens of Hondurans, from nonpartisan members of civil society to former Zelaya political allies, from Supreme Court judges to presidential candidates and even personal friends of Mr. Zelaya. Each relayed stories of a man changed and corrupted by power. The evidence of Mr. Zelaya's abuses of presidential power—and his illegal attempts to rewrite the Honduran Constitution, a la Hugo Chávez—is not only overwhelming but uncontroverted.

As all strong democracies do after cleansing themselves of usurpers, Honduras has moved on.

The presidential election is on schedule for Nov. 29. Under Honduras's one-term-limit, Mr. Zelaya could not have sought re-election anyway. Current President Roberto Micheletti—who was installed after Mr. Zelaya's removal, per the Honduran Constitution—is not on the ballot either. The presidential candidates were nominated in primary elections almost a year ago, and all of them—including Mr. Zelaya's former vice president—expect the elections to be free, fair and transparent, as has every Honduran election for a generation.

Hugo Chavez and the Emerging Crisis in Honduras

In his address to the U.N. General Assembly yesterday, President Obama told those in attendance that the people of the world 'will not long tolerate those who are on the wrong side of history. Yet on one of the major diplomatic issues of the day -- the stealth return of Manuel Zelaya to Honduras --President Obama himself is on the wrong side of history and is unfortunately detached from recognizing rising threats in our own hemisphere.

Zelaya was removed from office on the orders of the Honduran Supreme Court

after he violated his country's constitution. He is a puppet of Hugo Chavez, who supports terrorists and represents a real and immediate danger to those who believe in freedom. To support one of Chavez's puppets is outrageous and turns history and our obligation to our Latin American allies on its head

Hugo Chavez addressed the General Assembly and used that stage, as he has in the past, to advance his bizarre and absurd propaganda.

The American Security Council Foundation calls on

President Obama to make very clear while this media circus is going on that he both recognizes the Chavez threat and will begin to oppose Chavez allies, like Manuel Zelaya rather than support them.

The ASCF has a proud history of opposing leftist dictatorships in our hemisphere from before the Reagan era to today. President Reagan believed in "Peace through Strength" So do we, and so should President Obama.

The fourteen principles and goals of this strategy eventually became the cornerstone of the defense and foreign policy of the United States. This resulted in the successful conventional and strategic modernization program of the 1980's and it also led to America's vigorous support for free markets and democracy movements around the world.

The fundamental premise of this strategy was based on the

need for military economic and diplomatic strength, and it advocated using non-military means to stop and roll back Soviet expansionism. By sowing seeds of solidarity in an active public diplomacy program, the strategy strove to pressure the Soviets to abandon their goal of world conquest. This bipartisan strategy worked.

In 2001, the American Security Council Foundation worked in

cooperation with 94 U.S. lawmakers who contributed the development of a comprehensive new international security and economic strategy for the 21st Century. The lawmakers emphasized that serious security challenges remained, but the most imminent threat to the stability of the international system was in economic arena.
